Administrative Manager Vaughn discussed the proposed budget for FY 18/19 and answered general questions from the board regarding the budget. There is a proposed slight increase in the tax rate due to the increase of \$7K in the contract cost from the City of Tempe. Asst. Chief Silberschlag discussed a new station at Warner and McClintock that is proposed to open in 2019.
