Chair Kleespies opened the public hearing for comment. No public requested to speak at the meeting. Chair Kleespies closed the public hearing.

Item 6: Consideration of fully adopting estimates of revenues and expenditures for the fiscal year beginning July 1, 2020 and ending June 30, 2021 and declaring such to be the budget of the Tempe County Island Fire District (TCIFD #20-019)

Administrative Manager Vaughn reviewed the budget documents provided within the board packets and discussed the final budget for FY 20/21. Vaughn answered general questions from the board regarding the budget. The proposed adopted tax rate is 2.0091, up slightly from last year which was 1.9763. The tax levy is proposed to be \$226K TY, vs \$224K LY. The proposed budget is fairly constant compared to LY.
