Item 5: Consideration of establishing a tentative revenue and expenditure budget for the fiscal year beginning July 1, 2021 and ending June 30, 2022 pursuant to A.R.S. §48-853; declaring such for publishing and public notice; and setting July 26, 2021 at 5:45 p.m. local time for a public hearing prior to adoption (TCIFD #21-015). (Absent – Carter)

Administrative Manager Vaughn discussed the proposed budget for FY 21/22 and answered general questions from the board regarding the budget. The proposed contract cost from the City of Tempe is \$292,178. The contract cost went up \$63K due to the large increase in net assessed value in the Tempe County Island Fire District. There was a significant pipe replacement by Southwest Gas, which significantly contributed to the 148% increase in the county island's Net Centrally Valued Property. The proposed tax rate is 1.9021 with a tax levy of \$270K.

The board also discussed that they were conflicts with the July 26, 2021 meeting date. A new meeting date of Monday, July 19, 2021 was established for the budget hearing.
