Item 2: Consideration of appointing an interim member to vacant positions on the governing board pursuant to A.R.S. §48-852(B) (TCIFD #22-011)

Will Carter is interested in the vacant position on the Tempe County Island Fire District. There was a general discussion among the board.

b) Review of invoices / payables and authorization for payment (TCIFD #22-013):

The invoices for March and April (enclosed within board packet) were presented to the board for payment: PolicyLogic, LLC (\$2,122.88); Angela Bertram, CPA (\$292.50); City of Tempe -2^{nd} half of fire services contract (\$122,593).

Motion by Pierce/ 2nd Michell by: To approve the invoices in the amounts as presented; Passed 4-0. (Absent – J. Carter)

Item 6: Consideration of establishing a tentative revenue and expenditure budget for the fiscal year beginning July 1, 2022 and ending June 30, 2023 pursuant to A.R.S. §48-853; declaring such for publishing and public notice; and setting July 25, 2022 at 5:45 p.m. local time for a public hearing prior to adoption (TCIFD #22-014). (Absent – Carter)

Administrative Manager Vaughn discussed the proposed budget for FY 22/23 and answered general questions from the board regarding the budget. The proposed contract cost from the City of Tempe is \$245,187. The contract cost went down \$45K due to a decrease in net assessed value in the Tempe County Island Fire District. The proposed tax rate is 1.7855 with a tax levy of \$240K.

Motion by Michell/ 2nd by Pierce: Consideration of establishing a tentative revenue and expenditure budget for the fiscal year beginning July 1, 2022 and ending June 30, 2023 pursuant to A.R.S. §48-853; declaring such for publishing and public notice; and setting July 25, 2022 at 5:45 p.m. local time for a public hearing prior to adoption; Passed 4-0. (Absent – J. Carter)

Administrative manager Vaughn discussed the upcoming election and answered general questions from the board regarding the election. There are two board member positions that are up for reelection.
