Item 1: Review and approval of the governing board meeting minutes of July 24, 2023 (TCIFD #23-022):

Motion by Pierce / 2nd by W. Carter: To approve the July 24, 2023 meeting minutes; Passed 5-0.

Item 5: Consideration of renewing the district's general liability and associated insurance coverage with VFIS of Arizona (TCIFD #23-025).

Administrative Manager Vaughn provided an overview of the insurance services proposal by VFIS that had been distributed to each board member. There was a general discussion by the board concerning various components within the VFIS insurance proposal. The renewal premium was \$20,195 and the budgeted amount was \$20,250.

Motion by Pierce / 2nd Michell: To renew the general liability and associated insurance and policies with VFIS of Arizona and authorize the payment to Brown & Brown Insurance for the annual premium amount of \$ 20,195; Passed 5-0.

Item 6: Consideration of retaining a firm for the purpose of performing an annual audit of the district's financial records for the fiscal year ending June 30, 2023 pursuant to A.R.S §48-253. (TCIFD #23-026).

Administrative Manager Vaughn presented the proposal by SC Audit & Accounting Solutions for \$1,800. There was general discussion by the board concerning the engagement of each firm.

Motion by Pierce/ 2nd by W. Carter: To retain SC Audit & Accounting Solutions for financial audit services for the fiscal year ending June 30, 2023; Passed 5-0.
