Administrative Manager Vaughn provided an overview of the insurance services proposal by VFIS that had been distributed to each board member. There was a general discussion by the board concerning various components within the VFIS insurance proposal. The renewal premium was \$18,316 and the budgeted amount was \$20,000.

Motion by W. Carter / 2nd M. Conrad: To renew the general liability and associated insurance and policies with VFIS of Arizona and authorize the payment to Brown & Brown Insurance for the annual premium amount of \$ 18,316; Passed 3-0. (Absent - Clerk Sharlan Pierce, Kris Michell)

Item 6: Consideration of retaining a firm for the purpose of performing an annual audit of the district’s financial records for the fiscal year ending June 30, 2024 pursuant to A.R.S §48-253. (TCIFD #24-029).
